Respect and Community Values Committee (Tier 2)

2) Brief Description:

The Respect and Community Values Committee serves the campus community as a resource for issues surrounding a respectful campus environment.

3) Background:

In the summer of 2010 the UO Senate Ad Hoc Committee on Respectful Workplace was formed. The committee included all campus stakeholders, to make recommendations to the UO Senate regarding a campus wide cultural shift for a respectful workplace. The committee reviewed UO policies, Collective Bargaining Agreements (CBA), state and federal laws, and policies at other institutions of higher education. In the Spring of 2014 an Ombuds Program was established. The committee requested full committee status in the Fall of 2014. The committee chose its name in recognition of the bronze plaques located at the EMU Amphitheater with the same name.

5) Membership Requirements:

Members of the Respect and Community Values Committee shall be a total of seven (7) members chosen by their respective constituencies and shall include one representative from each of four of the five shared governance constituencies of Faculty, Officer of Administration, Officers of Research, and Classified Staff. In addition, there shall be one graduate student and one undergraduate student. There shall also be one ex-officio representative from the University Administration.
