#### Michael Schill, University President

#### <u>5 year report after implementation of UO Board of Trustees – highlights</u>

- Have worked steadily to improve UO's reputation nationally
- Revitalized our status as a member of the AAU
- Rebuilt relationship with University Senate and other campus partners, resulting in increased collaboration on various strategic initiatives
- Created a new budget model, increased growth in state funding, developed long-term financial plan, achieved philanthropic donations to more than \$2 billion
- Net increase of 72 tenure-related faculty and completed cluster hire project
- Reduced student-teacher ratios and increased overall student enrollment

#### **Challenges and Opportunities**

- Financial stability
- Strategic investments in a time of budgetary scarcity
- National skepticism about higher education

#### <u>Highlights: new Knight Campus during first year of operation:</u>

- Provided \$100k to students for travel, websites, social media amplification, etc.
- Working to create diverse hiring pools
- February 2020: hosting Deans of Engineering from OSU and WSU to discuss diversity in STEM
- Sponsored programing: new hires have brought in \$5 million in new grants, with an additional \$18 million in proposals currently being reviewed
- Associates and Affiliates Program: 40 UO faculty have signed up to participate
- 2018-2019: reviewed more than 300 applications for 4 faculty positions

#### **New Business:**

<u>US19/20-08: New Program Proposal: Bioengineering</u>; Nathan Jacobs (Knight Campus for Accelerating Scientific Impact), Jim Hutchison (Chemistry & Biochemistry),

- Brief review of presentation materials (similar to what was presented at Dec 2019 meeting).
- Information presented regarding ABET accreditation process for engineering programs.
- Program will harness talent of new faculty hires, with 6 of 12 to be completed by 2023 to meet program requirements.
- Program to be a model of experiential education, with an entrepreneurship component for interested students
- Target implementation date: Fall 2021

<u>US 19/20-09: Accelerated Masters Programs proposal</u>; Andy Karduna (Human Physiology, Grad School)

- Program template has been approved by Undergraduate Council and Graduate Council, with consultation of Registrar's Office for logistics and implementation.
- Review of presentation, with some material same as presented at Dec 2019 senate meeting.
- Program provides a third mechanism for reservation of graduate credit without change to existing policies.
- Several departments interested in developing Accelerated Master's Programs.

- ShakeAlert: \$7.5 million request
- Matching fund for research and teaching boat at OIMB in Charleston, OR 500k request
- Likely call to faculty for assistance in lobbying on Major Transfer Maps (MTMs), more info to senate in upcoming meetings
